1. I, **(Name)**, (Address), being of sound mind, revoke all prior Wills and testamentary dispositions, and declare this to be my **Last Will and Testament**.

2. **Special Instructions:**

I direct that all my legal debts, funeral, and testamentary expenses to be paid as soon as practicable after my death.

3. **Appointment of an Executor/Executor/Executrix (Personal Representative):**

I appoint (Name) as my Executor/Executrix hereunder and if he/she shall die before me or shall not act in that capacity for any reason, then I appoint as my alternate Executor/Executrix (Name) to act hereunder in his or her stead

4. **Guardians/s:**

If it shall be necessary to appoint a Guardian/s for any minor child of mine, I appoint (*) as such Guardians/s. If he/she/they fail to acy in that capacity for any reason, then I appoint (*) to servce as such Gaurdian/s.

5. **Trustee**

In the event that any trust shall come into existence as a result of this Will, I appoint (*) as Trustee thereof. If he/she shall fail to act in that capacity for any reason, I appoint (*) to act as Trustee.

6. **Residuary Estate**

I give the whole of my real and personal property to (*) although if (*) shall die before me, then I give the whole real and personal property to (8). Any gift in this clause to multiple beneficiaries is made to them in equal shares as tenants in common and is subject to the provisions of clause 7.

7. **Per Stripes:**

Should any beneficiary not survive me but die before me leaving a child or children living at the date of my death then that child or those children shall take the share (and if more than one as tenants in common in equal shares) of my estate which their parent would have taken but for her or his death.

8. **Trust for Minors, if any:**

My Trustee shall have full power to advance any part, or the whole, of my share of any beneficiary under the age of 25 years for the maintenance, education or advancement in life of such beneficiary. The money advance may be either from the income or principal of that beneficiary's share and the receipt of the guardian of the beneficiary shall be a complete release for my Trustee for any money advanced.

9. Beneficiary not surviving:

Subject to the terms of this Will, any gift to any beneficiary is subject to that beneficiary surviving me by 60 days, and should any beneficiary die before me or not survive me by 60 days than any gift the that beneficiary shall lapse.
